Cameron his heirs and assigns All that certain lot piece or parcel of land situate lying and being at North Lochaber aforesaid bounded as follows : On the West by main Post Road on the South and East by lands of the said Donald Cameron and on the North by lands of School Section X Containing one Eight of an acre more or less - the said lot being Eleven rods in length and two rods in breadth together with all and singular the buildings thereon with the casements and appurtenances to the same belonging and the revisions , remainders rents issues and profits thereof and all the estate right title interest Claim property and demand both at law and in equity of them the said Donald Cameron and Libby his wife of in or to the same To Have and To Hold the said above granted and described land and premises with the appurtenances unto and to the use of the said William R. Cameron his heirs and assigns forever And the said Donald Cameron and Lably his wife for themselves their heirs executors and administrators do hereby Covenant with the said William R. Cameron his heirs and that they the said Donald Cameron Signed 334 and Libby his wife have a good sure perfect and indefeasible estate of inheritance in fee simple in the said land and premises and have also good right full power and absolute authority to grant and convey the same in manner and form aforesaid accor ding to the true intent and meaning hereof and also that the said William R.
